

# **ATTENTION**

AS OF MAY 4, 2020, BY ORDER OF THE CONTRA COSTA COUNTY HEALTH OFFICER, TENNIS AND PICKLEBALL ARE ALLOWED RECREATIONAL ACTIVITIES **WITH CERTAIN RESTRICTIONS**. THESE COURT FACILITIES ARE AVAILABLE FOR UNORGANIZED RECREATIONAL PLAY ONLY. LEAGUE PLAY AND/OR RESERVED USE IS CURRENTLY PROHIBITED.

ALL ELEMENTS OF THE REVISED HEALTH ORDER MUST BE FOLLOWED AT ALL TIMES INCLUDING:

- ANYONE USING A SHARED OUTDOOR RECREATION FACILITY MUST PRACTICE SOCIAL DISTANCING
- USE OF PICNIC TABLES IS NOT ALLOWED
- RESTROOMS, PLAYGROUNDS & HIGH-TOUCH AMENITIES/EQUIPMENT REMAIN CLOSED
- USE OF SHARED EQUIPMENT IS PROHIBITED UNLESS YOU ARE A PART OF THE SAME HOUSEHOLD OR LIVING UNIT

COUNTY HEALTH SERVICES SOCIAL DISTANCING PROTOCOL IS REQUIRED AT ALL TIMES:

- DO NOT ENTER THE FACILITY IF YOU HAVE COVID-19 SYMPTOMS, OR A FEVER;
- MAINTAIN A MINIMUM SIX-FOOT DISTANCE FROM ONE ANOTHER;
- SNEEZE OR COUGH INTO A CLOTH OR TISSUE OR, IF NOT AVAILABLE, INTO ONE'S OWN ELBOW
- WEAR FACE COVERINGS WHEN YOU CANNOT MAINTAIN AT LEAST SIX FEET OF SEPARATION FROM OTHERS
- DO NOT SHAKE HANDS OR ENGAGE IN ANY UNNECESSARY PHYSICAL CONTACT
- HAVE HAND SANITIZER WITH YOU AND USE IT
