1. CIP and TIP General Plan Consistency – Review of the proposed 2015-2016 Fiscal Year (FY) Capital Improvement Program (CIP) and Transportation Improvement Program (TIP) for consistency with the adopted General Plan pursuant to Government Code Section 65401. Project Engineer: Robert Ovadia @ (925) 671-3470.

ACTION: The 2015-2016 Fiscal Year Capital Improvement Program and Transportation Improvement Program were reviewed and are consistent with the General Plan, 4-0. (Avila motioned, McGallian seconded.)

VII. PUBLIC HEARINGS

1. Industrial Mixed Use Text Amendment to the Development Code (PL15158-DC) - City initiated text amendment to the Industrial Mixed Use zoning classification of the Concord Development Code and recommend adoption of an Addendum to the 2012 SEIR for the Industrial Mixed Use Text Amendment to the Development Code. The proposed change would require a Use Permit to allow certain outdoor activities, storage or facilities that are compatible with the Industrial Mixed Use zone. ACTION: Recommended City Council adoption of an addendum to the 2012 SEIR for the Industrial Mixed Use Text Amendment to the Development Code, 4-0. (Avila motioned, McGallian seconded.)

Commissioner Avila recused himself for the next hearing item.

2. West Concord Mixed Use Text Amendment to the Development Code (PL15132-DC) – City initiated text amendment to the West Concord Mixed Use zoning classification of the Concord Development Code and recommend adoption of an Addendum to the 2012 SEIR for the West Concord Mixed Use Text Amendment to the Development Code. The proposed changes would prohibit certain uses including building materials, sales and services, cabinetry, and recycling centers. Those uses are proposed to be removed from the West Concord Mixed Use (WMX) zoning district because they do not conform to the WMX purpose statement under the Development Code or the uses envisioned for the WCMU land use designation under the General Plan. ACTION: Recommended City Council adoption of an addendum to the 2012 SEIR for the West Concord Mixed Use Text Amendment to the Development Code with modifications, 3-0. (McGallian motioned, Laub seconded.)
