**SUBJECT: INTERVIEWS FOR THE COMMISSION ON AGING, COMMUNITY
SERVICES COMMISSION AND CONCORD PLEASANT HILL HEALTH
CARE DISTRICT GRANT COMMITTEE****Report in Brief**

Interviews to fill up to seven (7) positions on the Commission on Aging, seven (7) positions on the Community Services Commission and five (5) positions on the Concord Pleasant Hill Health Care District Grant Committee are scheduled to begin at 3:30 p.m. on Monday, June 29, 2015 in the Garden Conference Room.

Background

The City Council opened this recruitment process on April 14, 2015 and set Friday, May 22, 2015 as the deadline for receipt of applications.

The recruitment for Commission on Aging is to fill up to seven positions for four-year terms ending June 30, 2019. There are currently seven members, three of which terms expire June 30, 2015.

The recruitment for the Community Services Commission is to fill seven positions, three of the positions for four-year terms ending June 30, 2019 and four of the positions for two-year terms ending June 30, 2017.

The recruitment for the Concord Pleasant Hill Health Care District Grant Committee is to fill five positions, two positions for four-year terms ending June 30, 2019 and three positions for two-year terms ending June 30, 2017.

On April 7, 2015 the City Council approved the separation of the Community Services Commission (CSC) and the Concord Pleasant Hill Health Care District Grant Committee (CPHHCDGC) into two separate bodies with the CSC consisting of seven members and the CPHHCDGC consisting of five members. Due to the restructuring of these two committees, this recruitment is to fill all seven members of the CSC and all five positions of the CPHHCD. The current members of the CSC were invited to apply for appointment.


