**SUBJECT: INTERVIEWS FOR THE CONCORD PLEASANT HILL HEALTH CARE
DISTRICT GRANT COMMITTEE****Report in Brief**

Interviews to fill five positions on the Concord Pleasant Hill Health Care District Grant Committee are scheduled to begin at 5:30 p.m. on Thursday, October 22, 2015, in the Garden Conference Room.

Background

The City Council announced the opening of this recruitment on July 14, 2015, then extended it and set Friday, September 25, 2015 as the deadline for receipt of applications.

The recruitment is to fill five positions, two positions for four-year terms ending June 30, 2019 and three positions for two-year terms ending June 30, 2017.

On April 7, 2015, the City Council approved the separation of the Concord/Pleasant Hill Health Care District (CPHHCD) Subcommittee from the Community Services Commission (CSC), forming two separate bodies with the CSC consisting of seven members and the CPHHCD Grant Committee consisting of five members. On July 7, 2015 the Council filled the seven positions for the Community Service Commission and asked the City Clerk to open a new recruitment for the Grant Committee.

A total of nine applications were received from Brent Trublood, Jacquelyn Martinez, Enrico Kevin P. Bunyi, James Mason, Maria Refugio Mata, Cindy Moreci, Niko Anagnostopoulos, Dr. Harmesh Kumar and Devlyn Sewell. Brent Trublood withdrew his application.

The appointment of applicants to the CPHHCDGC is tentatively scheduled for the City Council meeting of October 27, 2015.
